**WEIGHT:** **FLAT WEIGHT ONLY!** No weight allowance

**ELIGIBILITY:**

- Wrestlers in grades 7, 8, and 9 with PIAA defined junior high eligibility may participate.
- No wrestler with PIAA defined Varsity or Junior Varsity experience is permitted to participate.
- Any wrestler not governed by PIAA eligibility rules, who has represented a school or other educational institution in, or otherwise participated in, any state association sanctioned event against Varsity or Junior Varsity competition, regardless of the state where this has occurred, will not be permitted in the PAJW Jr. High (Boys) State Tournament.
- An 11 or 12 year old already in Junior High may participate in either the PAJW Youth (Boys) Tournament's 11-12 year-old division or in the PAJW Junior High (Boys) State Tournament, but cannot participate in both events.
- A wrestler who is not eligible for the PAJW Youth Tournament's 11-12 year-old division and not yet enrolled in Junior High (7<sup>th</sup> grade), may enter the PAJW Junior High (Boys) State Tournament.

**YOU MUST BRING A NON-RETURNABLE COPY OF YOUR BIRTH CERTIFICATE TO REGISTRATION OR YOU WILL NOT BE WEIGHED IN. NO EXCEPTIONS!**

**RESIDENCY:** You must be a full-time resident of one (1) of the following school districts to participate:

**SKIN:** Pre-existing skin conditions require a physician's completed medical release form at the time of registration. See your coach or download the proper PIAA medical form from the All Area website: [www.pajw.org](http://www.pajw.org)

**LACES, HEADGEAR & MOUTHGUARD:** Laces must be **SECURED**. Headgear is **MANDATORY**. Mouthguard **REQUIRED** to cover braces. PIAA Hair Rule applies.

**ADVANCING:** Double elimination tournament. The 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place finishers at each weight will receive a medal and will advance to the PJW Jr. High (Boys) State Finals February 28, March 1<sup>st</sup>, and March 2<sup>nd</sup> at the *1<sup>st</sup> Summit Arena* in Johnstown, PA. 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place will receive a t-shirt and shorts to be worn with their singlet at the State tournament. Advancers will receive an Information Sheet with details of the State tournament.

**OFFICIAL RULES AND ENTRY FORM**

1. Only full-time residents of Pennsylvania may participate in the Pennsylvania Junior Wrestling tournaments. Wrestlers must wrestle in the school district in which they are a resident.
2. There is a one-time entry fee of \$35.00 that must be paid at registration/weigh-ins. Weigh-ins are on **Sunday (February 23<sup>rd</sup>)** only. Checks are to be made payable to AREA VII Wrestling.
3. The source of rules governing the tournament will be the PIAA Rule Book (except as modified by Pennsylvania Junior Wrestling), PA Jr. Wrestling Rule Book and the Area Rules.
4. All Championship Bouts will consist of three (3) periods: 1:30-1:30-1:30. Consolation Bouts will be three (3) periods: 1-1:30-1:30. Overtime will follow PIAA overtime rules.
5. Headgear and wrestling uniforms are mandatory. Shoelaces must be secured with tape or straps in accordance with the PIAA shoelace rule. Mouthguard is required to cover braces. The hair rule will be enforced as adopted by the PIAA.
6. Wrestlers in grades 7, 8, and 9 with PIAA defined junior high eligibility may participate. No wrestler with PIAA defined Varsity or Junior Varsity experience is permitted to participate.
7. Any wrestler not governed by PIAA eligibility rules, who has represented a school or other educational institution in, or otherwise participated in, any state association sanctioned event against Varsity or Junior Varsity competition, regardless of the state where this has occurred, will not be permitted in the PAJW Jr. High State Tournament.
8. An 11 or 12 year old already in Junior High may participate in either the PAJW Youth (Boys) Tournament's 11-12 year-old division or in the PAJW Junior High (Boys) State Tournament, but cannot participate in both events.
9. A wrestler who is not eligible for the PAJW Youth (Boys) State Tournament's 11-12 year-old division and not yet enrolled in Junior High (7<sup>th</sup> grade), may enter the PAJW Junior High (Boys) State Tournament.
10. A NON-RETURNABLE COPY OF THE WRESTLER'S BIRTH CERTIFICATE IS REQUIRED AT WEIGH-INS.

**1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Place Finishers** in each weight class will receive a medal and advance to the Pennsylvania Junior High (Boys) State Championship in Johnstown, PA February 28<sup>th</sup>, March 1<sup>st</sup>, and March 2<sup>nd</sup>.

**ADMISSION:**                Adults - \$15.00, Students - \$10.00

**UNIFORM:** 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> place finishers will need **\$80 CASH-ONLY** for their Area VII singlet that **must** be worn at the Junior High (Boys) State Championship in Johnstown. You may pick up your uniform and information sheet after completion of your weight class. You will also receive a t-shirt and shorts. These are to be worn as warm-ups and in the Parade of Champions in Johnstown.
